In making this application I:

1. apply for membership of the Club competing in the CCCA competitions.
2. apply for registration with the above Club.
3. declare that I have not applied to play for any other Club within the CCCA this season.
4. acknowledge that the CCCA does not have any insurance cover which would assist me if I am injured or if property of mine is damaged. I realise that I must take out my own insurance cover if I want protection against such risks.
5. understand the damage that the sun's ultraviolet rays can cause and will take adequate care to protect myself against those.
6. waive all claims for liability against any participant and release every participant from all liability where that liability arises whilst I am taking part in any match, any practice activities or in any other activities associated with the game of cricket.
7. will NOT make any claim or take any action against the participants in relation to any loss or damage I may suffer, whether to person or property.
8. agree that I will observe and be bound by the laws of the game of cricket and the by-laws, rules and regulations of the CCCA.
9. acknowledge that I am aware of the Code of Conduct and that I am bound by that Code and will accept the ruling of the Judiciary Committee of the CCCA (subject to my rights of appeal).
10. confirm that I am under no outstanding financial obligation to any club and am not currently listed as a defaulter with either the CCCA, the NSWCA or the ACB or any affiliate of any of them.
11. am aware that the insurance held by the NSWCA will NOT provide any assistance if damage is caused to a vehicle parked at or near a cricket venue.
12. acknowledge that I participate in the competitions of the CCCA at my own risk.
